Asst. General Manager Community Letter

Happy Friday CRR!

I say happy Friday, but it's actually Wednesday as I'm putting this together. I'll be out of the office for Community Association Manager training until Tuesday next week, and will be back in the office Wednesday morning. I get a huge amount of email each and every day, and it's tough enough to keep up as it is, so I'm going to be super behind when I get back and will be playing major catch up for probably two days. I hope by next Friday I'll be writing one of these newsletters from a position of actually being caught up (fingers crossed).

As many of you have been asking, yes, we're getting somewhere on replacing the heater at the Rec Center. With the tightened controls in place, making a purchase of this size (roughly \$17K), especially an unplanned one, has to go through a significant process. Without going into all the exact steps and details, the Board has made a decision on what it believes is the best way to proceed. Once that happens it's "go time" as they say, and we're full speed ahead now.

What we had before was a heater that was undersized for the demands of the desired temperature point and size of the pool. As a result, the heater was overworked, broke down frequently, and finally reached end of life sooner than it should have.

This single, underpowered heater is being replaced by not one, but two heaters, each of which are larger than the individual failed heater. The failed heater was a 300K BTU unit, and we're replacing it with two 400K BTU units. There are different operating scenarios that should greatly extend the life of the new system. I don't have much time this week to go down the rabbit hole of details, but we'll be able to balance the workload, spread it out, alternate heavier loads, etc. Not to mention the fact that if we have an issue with one of the heaters due to a failed part or downtime due to required maintenance, we won't be without a heater entirely such as has been the case with the failure of the previous single heater.

I did want to get everyone an update on that project, but I need to go ahead and wrap this up as I have just a few minutes before I'm up against a hard stop.
