## CRRA Members Weekly Update

### **Asst. General Manager Community Letter**

Happy Friday CRR!

Business this week is the bathhouse door project, weekend weather, and a couple of PSAs on tubing and burning.

First up is the bathhouse door project. As many of you are likely aware, the bathhouses are no longer locked as they used to be, and as a result we're having an ever increasing issue with vandalism and other criminal activity taking place. Right now we're beginning a trial of a new access control system, so I'm not able to go into detail at this time, but we wanted to let everyone know that we're more than aware of the issue we're having and we're moving as quickly as we can on securing the bathhouse doors to get a handle on the problem. We do, of course, have cameras, but the cameras alone are not enough to stop what's happening. Our understanding is that this was an issue before the bathhouses were locked in the first place, and that securing the doors with an access control system went a long way to preventing the type of vandalism we're seeing. Damaged and destroyed property creates a loss to the community, so this is high on our priority list to address.

If you've not heard, there's a tropical system in the Gulf that's forecast to impact our area Saturday night through Sunday morning. Heavy rains are expected, and a flash flood watch is in effect during this window, so please take any advance precaution that may be helpful depending on where you're

located in the community.

Lastly, we have just a couple quick PSAs. The first comes from Gilmer County Public Safety: "Changes are coming to laws affecting Georgians who burn outdoor yard debris. As of July 1, 2021, landowners will no longer be required to notify the Georgia Forestry Commission of their intention to burn hand-piled vegetative matter. However, the legal responsibilities of those burning outdoor yard debris will be strengthened. The second PSA is regarding tubing. I recently received word from Kalem Burns, Game Warden First Class with the Georgia Dept. of Natural Resources Law Enforcement Division. He wanted to pass along word that DNR law enforcement will be actively monitoring our section of the river this summer and will be ticketing anyone without a life jacket. I'm following up for more detailed information on a number of specifics, but I wanted to at least mention it. I'll pass along another update once I get more information on the details.

Until next week CRR, stay dry this weekend!


